NOTIFICATION

In exercise of powers conferred by section 62 of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996, the Governor, Himachal Pradesh, after consultation with the Expert Committee, is pleased to make the following rules further to amend the Himachal Pradesh Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2008, notified vide this Department's Notification No. Shram(A)4-6/2007-BOCW dated 4th December, 2008 and published in the Rajpatra, Himachal Pradesh, dated 8th December, 2008 namely:-

Short-title

1. These rules may be called the Himachal Pradesh Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Amendment Rules, 2017.

Amendment of rule 271

2. In rule 271 of the Himachal Pradesh Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2008 (hereinafter referred to as the 'said rules'), for the signs, figures and words "Rs. 10,000/- (Rupees ten thousand) only", the signs, figures and words "₹ 25,000/- (Rupees twenty five thousand only)", shall be substituted.

Amendment of rule 275

3. In rule 275 of the said rules, for the signs, figures and words "Rs. 10,000/- (Ten thousand rupees) only", the signs, figures and words "₹ 50,000/- (Rupees fifty thousand only)", and for the signs, figures and words "Rs. 5000/- (Rupees five thousand) only", the signs, figures and words "₹ 25,000/- (Rupees twenty five thousand only)", shall be substituted.

Amendment of rule 277

4. In rule 277 of the 'said rules', for the signs, figures and words, "₹ 10,000/- (Rupees ten

thousand only)", the signs, figures and words "₹ 20,000/- (Rupees twenty thousand only)", shall be substituted.

Amendment of rule 278

5. In sub-rule (1) of the rule 278 of the said rules, for the signs, figures and words "₹ one lac/- (Rupees one lac only)" the signs, figures and words "₹ 2,00,000/- (Rupees two lac only)", and for the signs, figures and words "₹ 50,000/- (Rupees fifty thousand only)", signs, figures and words "₹ 1,00,000/- (Rupees one lac only)", shall be substituted.

Amendment of rule 281

6. For sub-rule(1).of rule 281 of the 'said rules' the following shall be substituted, namely:-
“(1) The Board may provide financial assistance for education of the children of members of the Fund at the following rates:-

Amendment of rule 282


